OFFICE ORDER

Functions & Responsibilities of the Minority Cell:

2. To monitor implementation of scholarship schemes, reservation policies (wherever applicable) and other welfare measures for minority communities.
3. To ensure compliance with UGC / Government of India / State Government guidelines concerning minority welfare and equal opportunity.
4. To organize sensitization workshops, awareness programmes, seminars and cultural events to promote harmony and inclusivity.
5. To recommend remedial actions, special coaching, scholarships, mentoring and other support mechanisms.
6. To submit periodic / annual report of activities and grievances resolved to the Competent Authority.
